Community Comment Period:

What can be done about garbage and trash concerns along the I-5 corridor?

Voiced by Neighbor Deborah

This area of the county is managed by the Department of Transportation (DOT). DOT cites decreased funding and staffing as barriers to clean up. Other WHDNA members cite various reasons for trash, one of which being due to increased homelessness.

Deborah states DOT will provide eco garbage bags upon request for volunteers who want to clean up on side streets but this is not allowed on the actual freeway. Deborah has printouts that she can share with WHDNA for those interested.

Member Alissa mentions that Michelle Belkot is our County Councillor and county concerns would go to her rather than the mayor of Vancouver
